TUITION SCHOLARSHIP PROGRAM

Sancta Familia Academy is a private school where tuition is the main source of income. This amounts to less than 50% of our operating costs. The rest comes from donations, gifts, and fundraising efforts of our parents, students and faculty.

Parents who wish to request financial assistance may apply by completing the Application for Financial Assistance. All questions on the Application must be answered fully and returned to school no later than July 1st.

Most tuition scholarship grants are in the range of \$500 - \$1,500. Some families will receive more and some less, depending on the severity of the need indicated by analysis of the answers on the questionnaire. Some will receive no assistance if the answers on the questionnaire indicate they are not in the category currently eligible for tuition scholarship.

Students and parents who receive a tuition scholarship are encouraged to avail themselves of opportunities to assist and support the various fundraising and service projects conducted by the school during the year.

It is understood that students to whom a tuition scholarship may be awarded are to apply themselves diligently to all academic work and, additionally, are to make positive contributions to the spirit and programs of the school.

It is also understood that the complete tuition cost less any tuition scholarship award is expected to be paid according to the schedule as a condition for attendance. Parents who feel they cannot meet this obligation after being notified of the result of their Application for Tuition Scholarship, may request return of any advanced tuition deposits for the 2014-2015 school year. For incoming students, this request must be made within ten (10) days of the mailing date of the answer from the Tuition Scholarship Committee.

Notice of tuition scholarship awards will be mailed to parents by August 1, 2014. There is no fee for processing the Application for Tuition Scholarship.

- Service hours are expected from each family receiving financial assistance.
- Should a family not maintain their tuition payments or not fulfill their service hour commitment during the first semester, financial assistance may be discontinued the second semester.
- In cases where the parents are divorced, normally the assets of both parents will be considered. If the custodial parent has remarried, generally the assets of the step parent will be included.
- Completed applications are considered in the order in which they are received.
