Please note that if a family has at least one full time student (4 or more classes in Secondary or an elementary student) they will be required to pay the entire fundraising fee of \$100.00 a semester.

Acknowledgment of Non-Refundable Registration Fee Commitment Monthly Tuition Payments and Attendance

I/we acknowledge that the family registration fee and the student enrollment fee are non-refundable. I/we further acknowledge that our student(s) will not be fully enrolled in SFA until such time as our complete registration and enrollment package is received and completed in its entirety. Failure to complete the forms as required or any missing documentation will result in unnecessary delays in processing.

I/we also acknowledge that tuition payments and attendance are due the 1st of each month August through May, and that a late fee of \$10 will be assessed after the 15th of each month if attendance has not been submitted. Late fees for tuition and monthly payments of enrollment fees may alos be assessed a late fee.

## PARENT RESPONSIBILITIES

As parents, you play an integral part in the learning process of your student while teaming with Sancta Familia Academy teachers. Parents must be committed to the parental responsibility for providing a quality, Christian education for their children in accordance with existing law.

- Parents must be in agreement with the school's purpose and spiritual objectives, and be willing to abide by the school's rules and regulations.
- Parents are responsible for enforcing the Student Code of Conduct should discipline become an issue.
- Parents are responsible for purchasing curriculum and supplies as outlined in the curriculum guides for each grade level before school starts, unless provided by SFA.
- Parents will be requested occasionally to help out with transportation for field trips, act as chaperones, or assist in special events.
- Parents are required to serve approximately 4 times each school year, helping in their child's classroom, cleaning the school, maintaining the outside of the building, etc. This requirement is broken down by semester of mandatory 2 cleanings per semester. You may elect to pay \$20 for each required duty instead of serving so that we may "hire" someone to fulfill your responsibility.
- Parents are requested to advise teacher(s) of any change in the home or student's environment that would affect the student's academic performance (i.e. vacation, prolonged illness, etc.).
- Parent questions or concerns regarding student performance or work should first be directed to the SFA teacher. If a parent is not satisfied with the outcome, the parent may request a meeting with the school Administrator. If satisfaction is still not obtained, the parent may request a special meeting with the School Board. Any decision of the School Board will be final.
- At least one parent must attend the mandatory parent meetings.
- Tuition must be paid on time, which is by the 15th of each month. A late fee of \$25 will be assessed if tuition is received after the 15th of the month. If tuition falls behind more than one month, your student(s) will not be able to attend classes until tuition is brought up-to-date. For example, September's tuition is due September 1st. If by October 1st, September's tuition has yet to be paid, then your student(s) will not be able to attend classes in October. If you are having financial difficulty, please contact the Administrator.
- Attendance forms are due the by the 15th of each month. A \$10 late fee per student will be assessed if they are received after the 15th of the month. Please attach them to your tuition payments. (August attendance should be sent in with September tuition before September 15th.
